The White Earth Reservation Tribal Council is currently seeking a qualified applicant who will be responsible for the medical practice of two Medication Assisted Treatment (MAT) programs located on the White Earth Reservation and Bemidji area. The Medical Doctor will function as a member of a multi-disciplinary team, to provide medical oversight of clinical addiction practices and provisions of care. The Doctor will provide medication assisted treatment to individual patients.

- Directs and oversees clinical aspects of MAT to meet program objectives and ensure compliance.
- Provides direct patient care face to face and via telemedicine for MAT participants.
- Coordinates care to improve health outcomes for patients, and consults with other MAT Medical prescribers employed through White Earth.
- Performs administrative tasks.
- Professionally represents organization in an exemplary manner.
- Performs other duties and responsibilities as required or assigned.

### Knowledge, Skills and Abilities:

- Knowledge of and ability to follow and apply the policies and procedures of the White Earth Tribal Council and the White Earth Behavioral Health Services.
- Knowledge of Federal laws, State laws, Tribal legal codes that apply to medication assisted treatment.
- Ability to work independently with limited supervision.
- Ability to travel independently to various White Earth treatment sites.
- Ability to prescribe appropriate pharmacologic and non-pharmacologic treatment modalities.
- Skill in personal computer and related software such as Microsoft Office (Word, Excel, Outlook), and internet.
- Ability to effectively communicate, orally and in writing with co-workers, staff and administration.

### Qualifications:

- **Current Licensure as a physician; M.D. or D.O.**
- **Active waiver with the DEA for prescribing Buprenorphine products.**
- **One year of MAT waived prescriber experience preferred.**
- **Valid Driver's License and insurance for travel between sites and other related businesses.**
