The White Earth Reservation Tribal Council is currently seeking a qualified applicant who will be responsible for direct services provided to clients referred for mental health services within the Tribal Drug Court. This position provides quality mental health delivery within a culturally specific treatment model; services are maximized for the public; billing is maximized for those services; and competency is maximized to consistently meet audit requirements.

- Provides assessments to referred clientele.
- Ensures clients are provided with mental health services.
- Participates in Clinical Supervision if not yet licensed.
