The White Earth Reservation Business Committee is currently seeking a qualified applicant who will be responsible on providing early childhood services to the ages 0-5 that may include, but not limited to: DC:0-5 assessment and ongoing individual and/or family psychotherapy, consultation with the Young Child Wellness Partnership established with the Health Division. This position will be physically located within Dream Catcher Homes Supportive services, and work with White Earth Health Division as deemed appropriate.

- Will make recommendations to contribute to the maintenance or restoration of health status of infants, toddlers, and pre-school aged population.
- Instruct, treat, observe, and evaluate clients and program exhibiting social and emotional problems affecting their health.
- Identify need for parental mental health services and facilitate referrals.
- Administer a variety of psychological test and assessment tools to assist in diagnosing mental health symptoms and behaviors to provide appropriate recommendations for treatment.
- Report abuse or neglect cases.
- Refer to resources to assist in recovery from mental or physical illness as appropriate.
- Provide clinical supervision as required for program.
- Observe young children in a variety of contexts and settings to assess and identify concerns.
- Instruct clients and families in coping with social and emotional response connected with their situations and provide ongoing assessment and intervention.
- Maintain accurate, detailed reports and records.

### **Knowledge, Skills and Abilities:**

- Knowledge of and ability to follow and apply the policies and procedures of the White Earth Tribal Business Committee, Tribal Health System and State and Federal laws relating to scope of practice.
- Knowledge of biological, behavioral and environmental aspects of emotional disturbances, mental health disability, and substance abuse.
- Knowledge and ability to adhere to HIPAA regulations.
- Knowledge and, skill in using a systemic approach to care that includes assessment, diagnoses, planning, intervention, consultation and referral.
- Knowledge of human systems, human behavior, and alternative practices.
- Knowledge and Skill in time management, problem solving, prioritizing, and crises intervention.

- Master's degree in the field of psychology, social work, marriage and family therapy, or related mental health field from accredited college or university and professional License: Possession of a current license to practice in one of the following fields: psychology, Clinical Social work, clinical counseling, or marriage and family therapy.
