#### **Elders Council**

Lucille "Teedo" Silk is present and provided updates.

The White Earth Reservation Council of Elders monthly meeting dates for 2023 schedule was provided to the Tribal Council. All meetings are held at the Village Nutrition sites. Teedo was elected for Wisdom Steps. Wisdom Steps is a partnership with the eleven Minnesota Indian Tribes. Teedo has participated in this programming since 1999. They will be holding the Wisdoms Steps Conference at the Shooting Star Casino this year. The Wisdom Steps Board letter was brought forward for Tribal Council approval.

## Concerns brought forward:

- Office hours for the RBC. It has been difficult to reach programs when needed. Recommendation to reach out to Tribal Council assistants.
- Round House:
  - Concerns with rats in this area and the safety of the elders
  - o Concerns with ice on the roof
- Mike Heisler, new White Earth Housing Authority Director. The elders would like to meet him and address their concerns. Recommendation to reach out to Mr. Heisler and invite him to the elders meeting.
- Day Labor:
  - o Assistance to help elders when they are in need
  - o They are having trouble getting to their tanks due to the snow
- · Price of Propane to heat homes discussion.

Michael LaRoque commented on getting our own propane company for our members to receive a better price and prebuying our own propane. Brief discussion held on day labor cleaning out the areas around tanks.

- Indian Health Service Concerns:
  - o Taxes taken from patients
  - Moral
  - Medicines
  - o Favoritism
  - o Being rude to members

Michael LaRoque commented on having meetings with Indian Health Service. Recommendation to get a letter of concerns for the Tribal council to address. Laurie stated that she has been go over all the notes from meetings for action items to address with the Indian Health Service. Michael LaRoque commented on the issues that they have addressed.

Suicide / Overdoses – Where do our members go for these issues. Programs need to address these
problems with follow-up.

Current Projects for Behavioral Health:

- Mens Acute Care at Jack Haw
- A Family Treatment Facility at the old Christian Retreat
- The Old Men's Acute Care Facility will have renovations completed

Cheryl stated that women and children need a place as well. There will be a Family Treatment Center. They currently have OMC for women and children. The elderly needs this information, so they are able to refer to these programs. Recommendation to place on their agenda to address their concerns.

Concerns with funeral homes were brought forward. The elderly has invited Donehower Funeral Home to their meeting.

Home Health Checks concerns brought forward. Cheryl stated the elders Advocate Program has been doing home checks for elders.

The elders will be attending the 2023 National Indian Conference on Aging September 25 -29, 2023, at the Harrah's Cherokee Casino Resort Cherokee, North Carolina.

## Mother's Day Powwow:

A brief discussion was held on powwows and the funding they receive. It is the responsibility of each Powwow Committee to spend money on the powwow obtaining receipts and signatures. After each powwow event, receipts should be turned into finance. This is a donation and can hold accountability. If they spend more than the funding allocated, they can be reimbursed for anything over. This is bringing accountability for the funding. Brief discussion held on the following finance procedures. For White Earth large powwows, we need to follow Finance procedures. This is something that needs to be established for all the community powwows. Recommendation to provide names of all powwows and budgets.

There can be other programs to help with the cost and send to the donations committee. If they cannot help with the cost, they can bring it back to the RBC. Recommendation to refer to programs for assistance to help reduce costs. Recommendation for Antonio to draft a letter with a disclaimer for powwows and start a committee moving forward for consistency on what Powwows RBC will fund. \$35,000 is allocated currently for community council powwows. Each powwow committee will need to sign a disclaimer.


