- whereas, the White Earth Reservation Business Committee is the duly elected governing body of the White Earth Reservation pursuant to Article VI, Section 1, of the revised constitution of the Minnesota Chippewa Tribe, as amended, and organized under Section 16, of the Act of June 18, 1934 (48 Stat. 984), and
- WHEREAS, the White Earth Reservation Business Committee is the duly authorized governing body of the White Earth Band, and
- WHEREAS, the White Earth Reservation Business Committee is charged with the responsibility of administering the contractible functions of the WELSA Program in accordance with P.L. 99-264, and
- WHEREAS, the White Earth Land Settlement Project has funding within the budget to pay for the Technician and Programming Services, and
- WHEREAS, White Earth Land Settlement Project requests to enter into a contract with Lewis Consulting, Dwight Lewis, 9309 Littlebass Lake Road N.E., Bemidji, MN 56601 for the Computer, Software and Programming Services, and
- WHEREAS, the Tribal Executive Committee("TEC") of the Minnesota Chippewa Tribe has the authority to make final interpretations of the Constitution of the Minnesota Chippewa Tribe, and
- WHEREAS, the TEC interprets the language of the Constitution to mean that the delegation of authority is given to the Reservation Business Committee (also known as the Tribal Council), and
- WHEREAS, the Minnesota Chippewa Tribe Constitution, Tribal Interpretation 8-94, statesin Article VI: Section 1. Each of the Reservation Business Committee shall, in accordance with applicable laws or regulations of the Department of the Interior, have the following powers:
  - (e) To delegate to committees, officers, employees or cooperative associations any of the foregoing authorities, reserving the right to review any action taken by virture of such delegated authorities.

THEREFORE BE IT RESOLVED, that the White Earth Reservation Business Committee hereby authorizes the White Earth Land Settlement Project to enter into a contract for Technician and Programming Services with Lewis Consulting, Dwight Lewis starting January 1, 2024 to December 31, 2024.

**BE IT FURTHER RESOLVED,** that the White Earth Reservation Business Committee hereby authorizes White Earth Executive Director or Chief Operating Officer to sign all necessary documents for the Technician and Programming Services contract with Lewis Consulting, Dwight Lewis for the White Earth Land Settlement Project.
