- Ability to work cooperatively within Behavioral Health Service, White Earth RBC, local, State, and Federal meetings, • committees and/or boards to make the work of the group successful and effective.
- Skilled in leadership techniques, production methods, and coordination of people and resources.
- Knowledge of DAANES reporting.

## **Qualifications Required:**

- Bachelor's degree in the Human Services, Behavioral Health, or a related field preferred; or four (4) years of experience providing substance use disorder, mental health, or social services; or an equivalent combination of education and experience.
- High School Diploma or GED required.
- UMICAD I certification required; UMICAD II, or III certification or Licensed as an Alcohol and Drug Counselor (LADC) • preferred.
- If not certified as UMICAD II or III or an LADC, must obtain certification/licensure within two (2) years of hire. •
- Minimum of one (1) year of supervisory experience in a healthcare, behavioral health, or social services setting preferred.
- Two (2) years or more experience working in Native American communities providing culturally appropriate services.
- Must be free of chemical use problems for at least the two years immediately preceding hiring and must sign a statement • attesting to that fact and freedom from chemical use problems must be maintained during employment.
- Must have a valid driver's license, be insurable by agency driver insurance, and have adequate vehicle insurance for travel • between sites and other business-related destinations.
- Successful completion of a criminal background check.
