Dear White Earth Band Members and Community:

The White Earth Reservation Business Committee hereby announces that a General Election will be held on June 11, 2024 on the White Earth Reservation.

This General Election provides for a April 2, 2024 Primary Election in the event there are more than two (2) eligible candidates for the open position.

Elected positions to be filled are as follows:

- 1. Chairman White Earth Reservation Business Committee-Four (4) Year Term
- 2. District IIII Representative-White Earth Reservation Business Committee-Four (4) Year Term

Candidates shall file with the Secretary/Treasurer or his designee Christie Haverkamp. White Earth Compliance Division, 779 E Jefferson Ave, Mahnomen MN during regular business hours beginning on January 12, 2024 at 8:00 a.m. Filing will close on January January 22, 2024 at 4:30 p.m.

The Election Ordinance (Revised 12/11/2023) provides that if a candidate receives more than half of the votes cast for that position in the primary, that candidate is the winner and no further election is required for that position.
