Upcoming School Year: Integrate Immersion into our classrooms

Tamarac National Refuge: Meetings this week were held with the US Fish and Wildlife regarding managing Tamarac. White Earth is putting in another MOU for the co-stewardship before we get into the negotiations of a 60-day contract with the US Fish and Wildlife. Annual Funding Agreement (AFA) that comes with Tamarac. White Earth has to follow the processes.

White Earth State Forest: Continued discussions with Minnesota DNR. Having another meeting to talk about the MOA and the next cycle of legislation.

Continuing to work with the counties and our council members have been working diligently with Becker County, Mahnomen County and Clearwater County. White Earth is being proactive when we talk about our resources within our boundaries. We want to protect our medicine and water. The RBC will be meeting with the Ag Council on how we are protecting our water and upholding out inherit rights of sovereignty of our water. White Earth is making headway across the country with some of our ordinances and laws that we create here within White Earth. Protecting our water and our Manoomin.

I.H.S Clinic Openings: White Earth and Naytahwaush Clinics. White Earth is striving to becoming that Sovereign Nation that self-governs. Only three Nations have direct services; Red Lake, Leech Lake and White Earth and that we will run our own clinics as part of self-determination and working towards.

Employees working for RBC: White Earth Nation believes in our businesses especially Shooting Star Casino and Waabigwan Mashkiki. RBC did another pay raise for Shooting Star Casino up to \$19.00 an hour for minimum wage. Continuing to support our employees and how to move forward for the future of White Earth to depend on ourselves as a Nation.

Michael LaRoque, Secretary/Treasurer provided a brief quarterly report.

Secretary/Treasurer LaRoque provided his quarterly written report to the RBC for review. The report will be posted to the White Earth website and Anishinaabe paper. Any member who would like a copy, please reach out to the Secretary/Treasurer LaRoque.

Impact Aide Funding: received the amount of \$6.9 million from the State of Minnesota and will use on October 1, 2024.

Tribal Council will be meeting with the commissioner of Finance, Paul Markward and renegotiating our tax agreements.

Secretary/Treasurer Michael LaRoque will be meeting with Tracy Lhotka - CFO, Divisions and Behavioral Health to review budgets for the upcoming fiscal year. White Earth has been within budget the last couple of years and have not approved any budget amendments other than our capital projects and land purchases.

Urban Members: RBC has been meeting with them and including them on the State of the Band, Elder's Picnic and for the Inauguration. To help our members engage in the community.

MCT meeting was held in Boise Forte. They voted Secretary/Treasurer LaRoque as the President of the Minnesota Chippewa Tribe. Many agenda items need to be addressed at the TEC level, Land Transfer and the List Act. The MCT land transfer is still on resolution with MCT. White Earth has a lot of questions on these two issues and need to be addressed. The Chairman stated to please reach out to our delegates for more information.

RBC met with the Indian Health Service staff regarding 638 negotiations. RBC will be placing information out. Attended the White Earth Enterprise and Waabigwan Mashkiki Board monthly meetings. Enterprise purchased a neon sign and will be placing their advertisement on this board.

White Earth's Annual Powwow celebration went very well. RBC approved minimal wage increase at the Shooting Star Casino.

Animal Control Department: A meeting will be held with Missy and Tara regarding where the funding will come from. There will be funding coming through for spade and neutering clinics from the Humane Society.

Tiwahe Initiative: White Earth which was selected as an Incubator Tribe will receive the Tiwahe Initiative budget of \$100,000 per year. Secretary/Treasurer LaRoque provided a brief overview of the Tiwahe Initiative.


