White Earth and Twin Lakes split the cost of \$51,000. Last couple years they received \$25,831.00. Recommendation to pull the equipment replacement reserve for the Impact Aide funding. Resolution Division of Natural Resources – Co-management of White Earth State Forest and letter. White Earth has been in discussions with the Minnesota Department of Natural Resources to begin the process of returning the lands of White Earth State Forest back to the White Earth Reservation. Motion made by Michael LaRoque to approve Resolution No. 057-24-005; second by Eugene Sommers. Motion carried: 4 for, 0 against.

I.H.S 638 Letter of Intent. White Earth is looking at 638 of our health and starting the process. The White Earth Tribal Council is exploring contracting or compacting the White Earth Indian Health Services Units:

Cyndy Rastedt and Gina Boudreau. are present to update their Public Health Accreditation. They are going through their accreditation standards for the local and the state governments here on the White Earth Reservation. A brief overview of the Role of Tribal Public Health & Highlights from the Tribal Community Health Assessment.

- White Earth Nation Tribal Public Health focuses on population health win an aim of understanding and improving the health of our entire community, rather than focusing on individual health issues.
- The mission of White Earth Nation Tribal Public Health is to promote "wiikwazom" wellness, prevent "gibichichige" disease, and protect "ganawendan" health in a way that honors our Anishinaabe culture.
- We work toward improving the health of our community in partnerships with many tribal, state, and federal partners.

The Chairman commented on the hard work of the White Earth Nation Tribal Public Health and team.

Elders Homeowners Repair:

The Secretary/Treasurer, Michael LaRoque stated the Tribal Council placed \$1 million dollars into the elder home repair fund. \$700,00 for major repairs and \$300,000 for minor repairs. The RBC has been working diligently for the last couple of years. The Tribal Council has been assisting the elderly who need emergency fixes on their homes first. The proposal for today is they have ARPA funding to put towards the elderly home repairs and can make an amendment to the budget. \$500,000 will be added to this existing program. White Earth Builders did the assessments on each home and contractors will complete the jobs; however, RBC would like to hire one person to lead this program.

Brief discussion held on who will run this program. This will be for homeowners. Brief discussion held on when the ARPA funds will end. They would start with the elderly who are in need. This is for emergency situations.

Elder Homeowners Repair Fund Budget Amendment:

# **Elders Commission**

Pam Aspinwall is present and provided a brief overview of their November 15 meeting. The Council of Elders were invited to this meeting. Francine Day, Treasurer and Pam met with Don Dalve to help assist them with their budget. Recommendation was to have Ayecia facilitate this for them.

New Business: A budget that they have approved in their commission meeting did not get in for FY24.

Tasks: One of their tasks is to be in contact with programs that serve the elderly. Defined within their Bylaws is to choose 2 different Programs that serves the elderly specifically and to offer their support. Pam will be involved in the Elder Nutrition Program and will support.

Public comment on issues and concerns brought forward regarding the Elders Commission's membership. The Council of Elders bylaws were referenced to the RBC regarding membership. Comments on the membership form brought forward and concerns. NICOA trip concerns brought forward.

NICOA: Members should attend the meetings to be able to attend this conference. The Elders Commission holds meetings in each community for elders to attend. They have limited funding and bring forward requests to the RBC when they have limited funding. They also hold fund raisers for this event. They do what they can with their limited funding. Recommendation to attend at least four meetings a year to be eligible to attend the NICOA conference.

They work for the elders of the White Earth Reservation and have been doing this for 20 years. They do not have a budget. The commission receives \$5,000 a quarter, \$20,000 a year.

Concerns brought forward regarding voting.

The Secretary/Treasurer, Michael LaRoque, stated they have established their bylaws. Elders can review bylaws and they need to follow these. They also can request for changes. This is a recommendation. Teedo stated working for one purpose is working for the elders of the White Earth of Reservation.

# **Elders Council**

Lucile "Teedo" is present and provided briefs updates. Teedo referenced a letter to the RBC regarding the Elderly Nutrition Sites.

The Secretary/Treasurer, Michael LaRoque, commented on a proposal brought forward by Kathy Thompson. A meeting will be held with the Tribal Council, Council of Elders and Elders Commission on this proposal. They are making the Naytahwaush and White Earth ENP sites the hubs. A brief overview on how the hubs and sites will work. Kathy Thompson will be having the meeting to move forward. The kitchens are closed; however, the sites are open.

Teedo commented on these sites being a place for elders to gather.

Curtis stated the goal is to keep the cost down and to keep the sites open.

District III Representative, Cheryl commented for clarification on the hours the ENP sites are open and work. Brief discussion held on the meal's delivery for the elders. Brief discussion held on the grant funding. Recommendation to hear from Kathy Thompson and staff for both sides to be heard.



# **Peebles Kidder LLP Agreement** – *Table*

Michael Nuesser, Northwest Minnesota Foundation is present and provided a brief update on MACP Programming.

- Community Center Funding: \$3 million funding for our region, focused on community centers that meet the goals of health, work, and education components.
- \$4.6 million for native youth mental health and wellness. They promised \$3 million dollars
  to fund: Red Lake, Cass Lake, and White Earth each will receive \$1 million.
- Children and Families Program. \$50,000 was provided to the White Earth Brain Conference.

B&G club centers for each community. Combined with Behavioral Health. Cultural center for our sacred items home and having them protected and the history of our people. Cultural centers for each community and they have this space. What direction to take?

What is MACP able to focus on. MACP is not into capital projects. They are into programming. They are using the MN foundation in order to disburse these funds due to knowing these areas best.

A brief discussion held on funding these areas is provided. MMCDC and Northwest Foundation. A discussion on an area specifically for youth and cultural centers. Can the Tribe go after funding from both foundations?
