Information Technology (IT) Division Monte Bellanger IT Director Tribal Affiliation Enrolled member of White Earth Nation

The White Earth Information Technology (WEIT) Department provides direct oversight and governance of the company's technological systems, maintenance of the infrastructure and functionality of the systems overall.

The mission and primary goal of the White Earth Nation IT Department is to make sure that all technology operations are running smoothly so the White Earth Nation can provide services to its members.

The White Earth IT Department installs and maintains all information technology systems. Additionally, WEIT provides information security, computer support, and end user support for all Divisions at White Earth Nation. This can include installing new software and hardware, repairing hardware problems, troubleshooting computer problems, and training end users on using computer systems. All computers, printers, and server hardware are ordered through the IT department. The IT department has its own divisions. These divisions are helpdesk, applications, systems, networking, and security.

White Earth IT also assists with other tribal entities to provide IT support when possible. IT will also aid in supporting and training tribal members on technology needs when asked.

INFORMATION TECHNOLOGY

Tribal Public Health Division Pat Butler Tribal Health Director

The mission of the White Earth Nation Tribal Health Program is to improve the health and wellbeing of the White Earth Nation through the service of our dedicated team who work within our programs.

During the COVID-19 Pandemic, the White Earth Tribal Health Division continued providing essential services such as Ambulance Services, Elderly Nutrition Program (ENP), CHR Transportation, Public Health, LIFE Maternal Child Home Visiting, and Home Health Nursing Services. In addition, to providing services, new ways of service delivery which had not been done before had to be developed to serve the people of White Earth. With these new efforts and the need to keep members safe the Health Division provided 19,440 vaccines and performed case management, education, and contract tracing to 34,774 persons.



The WELSA Department is responsible for the settlement of claims on certain lands within the boundaries of the White Earth Indian Reservation. Collaborating with the Office of Hearings and Appeals for the probate process. The location of heirs for the issuance of Monetary Compensation.

These functions are briefly explained as:

Analyze title issues. Obtain and review information from National Archives, Department of Interior and Minnesota Counties.

·Prepare Claim for Publication in the Federal Register.

•Research and Compile Family History. Gather information supporting the Federal and Minnesota Inheritance Laws.

•Provide Probates to the Office of Hearings and Appeals (OHA). Testify at hearings held by OHA.

•Prepare Compensation Award Letters by calculating a value for Undivided Interests inherited

Coordinate bi-weekly and monthly staff meetings to review processes, data, and timelines of program.

White Earth MAT: White Earth MAT program serves an average of 80 individuals each month.

Circle Back Program and Juvenile Healing to Wellness: Maple Syrup camp for the first-time spring of 2022 Halloween event at Christian Retreat for over 2,700 attendees. Halloween Dance on October 14th, 2022 for 250 attendees Thanksgiving feast and community bingo in November for 100 attendees.

White Earth Economic Development Division provides the following services:

- Assist the White Earth Reservation Tribal Council with economic development strategies, community planning, revitalization strategies and business development.

- Assist White Earth Tribal members with business plans, proposal preparation, start-up assistance, applications, technical support, and locating financial support.

- Create, implement, and direct effective economic development strategies that improve the overall economic conditions for residents of the White Earth Reservation

- Establish economic development programs and practices that lead to private sector projects on the Reservation that result in capital investment, job creation, creative and niche development, and/or other quality developments.

- Grant writing assistance, enabling our Tribal programs to grow and strengthen their programming to better serve the people of White Earth Nation.

Our Planning department and team of grant writers have successfully written several grants, with award funds totaling \$19.2MM in 2022. Special recognition goes to Pam Keezer, for her exceptional work writing grants and assisting her fellow grant writers.

Economic Development has been awarded grant funding in the areas of renewable energy and broadband, both of which are program goal areas and priorities.

White Earth Compliance Division:

Adult Basic Education: 19 Graduates in 2022.

Boys & Girls Club:

Announces \$1.25 million Gift from MacKenzie Scott June 11th, 2022. Fashion show with club youth held at the Shooting Star Casino on August 22nd.

Wild rice camp held with youth at Little Elbow August 16 & 18th.

Child Care:

New Playground Equipment was installed in 16 licensed Child Cares. Operating our Maamigin Achigaazo (The Gathering Place) and providing library and play spot services for the community and early childhood programs.

220 children are receiving services in our tribal licensed centers/home family childcares.

Head Start:

As of March 2023, 98 children were attending the White Earth Head Start Program classrooms; 30 children were enrolled in Early Head Start home visiting services.

White Earth Indian Child Welfare provides case management services to families that are eligible for ICWA services.

Foster Care Program:

The Foster Care Program provides care on a Tribal level to our children when their parent or caretaker is unable to do so. Foster parents are to be committed to the sacredness of our children: respecting, honoring, and nurturing them when they are faced with the trauma of being separated from their parents. The Tribe and foster parents are responsible for ensuring that children receive the highest care possible. In FY2022 this program had 87 licensed foster homes.

ICW's Parent Support Outreach (PSOP) and Voluntary Services Program provides services to families as a prevention method, helping families who are at risk of entering or reentering the child protection system and/or out of home placement. ICW assists all families we serve who are seeking a cultural way of life and teachings. In FY2022, this program served 35 families (35 parents, 38 children).

Recently, the Child Protection Program collaborated with the White Earth Tribal Court and conducted our first reunification ceremony. We celebrated the hard work and efforts done by this single parent, who successfully completed their requirements of their child protection case plan and courtordered services. In FY 2022 this program serviced 132 families (125 adults, 152 children). ICW had a total of 92 children In either foster care or preadoptive homes. 66 children were on trial home visits, in their reunification homes.

INDIAN CHILD WELFARE

White Earth Judicial Services Lori Thompson Court Services Manager Tribal Affiliation First Generation Descendant of White Earth Nation

Summary of Services Provided:

The White Earth Tribal Court consists of a Chief Judge and two associate judges. All White Earth judges must be licensed attorneys and abide by the White Earth Code of Judicial Conduct.

The District Court handles civil regulatory matters including, but not limited to, child welfare, juvenile court, civil commitments, marriage licensing, divorce, child custody, alimony, visitations, child support, name changes, protection from domestic abuse (OFP), adoptions, guardianships, small claims, traffic matters, and natural resources.

The White Earth Appellate Court consists of a Chief Justice and two associate justices. Appeals from the District Court are heard by a panel of three Appellate Court Justices.

Guardian ad Litems (GAL) are available through the court. They are appointed to investigate what is in the best interest of the child in matters such as child protection, order for protection, custody, and divorces.

Accomplishments: 2022 Recipient of the President's Award from the Minnesota Department of Corrections Association.

JUDICIAL SERVICES

White Earth Cultural Division Merlin Deegan Cultural Coordinator Tribal Affiliation Enrolled member of White Earth Nation

The White Earth Nation Cultural Division exists to help ensure culture is being integrated into the programs, events and schools on the White Earth Nation.

Another main focus is to preserve the Anishinaabe language and encourage White Earth Nation people to continue practicing it. Incorporating culture in our every day lives will help our quality of life. Take part in our cultural community outreach activities such as beadings, quill work, dance groups, drum making, singing and drumming, and more to get involved and keep our heritage alive.

White Earth Tribal Nation history, communities, language, land, natural resources, natural medicines, oral stories, foods, gardens, economy, and the physical, spiritual, cultural, and our way of life are preserved for our future generations.



Public Works Division Michael Bowman Sr. Public Works Director Tribal Affiliation Enrolled member of White Earth Nation

The Public Works Division consists of five departments; Fleet, Transportation, Water and Sewer, Water and Sewer Construction and Transit.

The White Earth Department of Transportation maintains 150 miles of roads on the Reservation. Services provided include snow removal in the winter. Blading the aggregate roads year around as well as additional aggregated as needed. Brushing and crack sealing along the road way are also included in our services.

The Water and Sewer Department handles water and wastewater systems in our tribal communities of White Earth, Naytahwaush, Pine Point, Rice Lake, Elbow Lake and the Chippewa Ranch. Collectively water produced and treated are approximately 175,000 gallons per day. Tribal systems consist of water treatment plants in each community as well as several wastewater lift stations pumping sewage to the treatment ponds.

White Earth Public Transit offers safe, reliable, affordable transportation to programs and people of the White Earth Reservation and the surrounding area. White Earth Public Transit works with other departments and clients to schedule rides through our dispatch center.

White Earth Fleet is the official auto maintenance and repair team for not only White Earth program vehicles, but is open for White Earth membership as well. From anything like standard oil changes and tires, to major mechanical work and everything in between, depend on the brand that keeps White Earth moving.

PUBLIC WORKS

Human Services Division Michael Thompson Human Services Director Tribal Affiliation Enrolled member of White Earth Nation

Elders Vulnerable Adult Protection Program has assisted 300 plus elders and vulnerable adults with various services.

Financial Services provided services for 2,776 cases in 2022. The growth of the program now has 5 locations that include, Bagley, Naytahwaush, Mahnomen, Detroit Lakes, and Pine Point.

White Earth Food Distribution is a federal program that has been in operation since 1980. White Earth & Leech Lake were the first to pilot the program in 1979. There are 450 customers that enjoy their shopping experience each month. Sixty homebound customers receive home delivery services each month.

Feeding Our Families Food Program is serving a monthly average just over 400 families, around 1000 individuals, 240 elders, 370 adults, and 380 children.

Omiimii Wadiswan Equay (DOVE) Shelter mission is to provide shelter services to women and their children who are experiencing current victimization of domestic violence, sexual assault or trafficking. The White Earth Child Advocacy Center is the first tribally operated Child Advocacy Center in the state of Minnesota. Since opening in March 2022 it has served 40 plus children and their families.

White Earth assisted 800 households with Covid emergency rental assistance grant from the US. Treasury. Which totaled 2.8 million in assistance used for rental and utility assistance.

HUMAN SERVICES

White Earth Enterprise RaeAnn Smith Executive Director Tribal Affiliation

White Earth Enterprises, LLC's continues to stimulate the economy of the Tribe and to create employment opportunities for tribal members and surrounding communities as part of the economic arm of the Tribe.

White Earth Building Supplies, LLC recently remodeled the storefront and floor area to expand and enhance our lumber, plumbing, building materials, power tools, carpentry, and paint supplies.


White Earth Business Products, LLC has recently updated our equipment to create larger in-house embroidery on apparel and now offer in-house custom branding for customers and their businesses.

White Earth Builders, LLC offers project management construction services. White Earth Builders latest projects have included completion of Jackhaw Men's Acute Care Facility Phase I, Pine Point Clinic, renovation of Food Distribution facility, updates to the Mahnomen Ag Building, and new roofing at the White Earth Congregate Building.

White Earth Sanitation, LLC provides solid waste disposal services within the boundaries of the reservation to over 2,100 customers and businesses.

Waabigwan Mashkiki, LLC is the medical cannabis factory and dispensary operating under the White Earth Cannabis Control Code. Waabigwan Mashkiki, LLC strives to provide product to eligible patients. The facility building renovation is nearing completion. Waabigwan Mashkiki is working with the Cannabis Regulatory Commission preparing for the initial opening and dispensing of products.
